It's March, and time to celebrate ladder safety month! This month-long initiative is dedicated to raising awareness about the critical role of ladder safety in preventing workplace accidents and promoting a culture of safety within our communities.

Ladders are among the most commonly used tools across various industries, from construction and maintenance to manufacturing and beyond. While ladders serve as indispensable tools for accessing heights, they also pose significant risks if not used properly. According to the Occupational Safety and Health Administration (OSHA), falls from ladders are one of the leading causes of workplace injuries and fatalities.

As advocates for workplace safety, it is our responsibility to ensure that every individual who utilizes a ladder is equipped with the knowledge and resources necessary to do so safely. Ladder Safety Month provides us with an opportunity to reinforce best practices, educate our workforce, and implement proactive measures to mitigate the risks associated with ladder use.

The American Ladder Institute offers a website, www.laddersafetytraining.org, that recommends educational resources that assist in distribution of informational materials, and pre-operational planning.

I encourage your organization to join us in observing Ladder Safety Month by prioritizing ladder safety within your workplace. Here are a few actionable steps you can take:

- Conduct comprehensive ladder safety training for employees who use ladders as part of their job duties.
- Regularly inspect ladders for any signs of damage or wear and tear, and promptly remove defective ladders from service.
- Provide proper instruction on ladder selection, setup, and usage, emphasizing the importance of maintaining three points of contact at all times.
- Implement a ladder safety policy that outlines clear guidelines and procedures for ladder use, storage, and maintenance.
- Encourage a culture of safety by promoting open communication, reporting of hazards, and peer-to-peer accountability.
- By prioritizing ladder safety, we can significantly reduce the number of ladder-related accidents and injuries in the workplace, ultimately saving lives and preventing unnecessary suffering.
- Thank you for your commitment to workplace safety and your continued involvement in ASSP. Together, we can make a difference and ensure that every worker returns home safely at the end of the day.
